Thank you for contacting Hatfield Spraying Service, Inc concerning our gypsy moth suppression 2022 for neighborhoods and home owner associations program.

I apologize for the delay in getting the requested information about 2022 GM program we are able to offer. There have been several factors that we had to determine on how they might affect the program differently than 2021.

The cost of the 2022 program is \$65/ acre with a 50-acre minimum or (\$3,250 minimum charge). All properties must be in 50 acre consecutive blocks. If your group has over 1,000 acres please contact me for special pricing.

I am sending you a consent form for your group to complete. We will need the consent form return along with a copy of your area's plat map outlining the property that needs to be treated. The map and consent form are due to our office no later than Friday April 15, 2022. Once you have submitted the consent form and maps HSS will also sign the contract and return an executed copy to you for your records.

.Full payment is due prior to application and is due by Friday May 13, 2022.

Depending on the weather the application usually takes place the end of May but can be as late as the beginning of June. In 2021 the application was made the week after Memorial Day and the 1st two weeks of June. We will notify the contact you provide when we are getting closer to the time of application. A point of contact email is the preferred method to communicate these application updates.

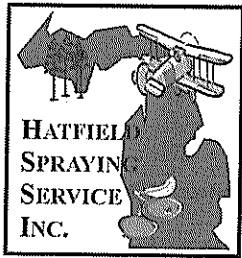
